# **Carrington Work Local Scholarship/Loan Repayment Program**

# **Introduction**

The City of Carrington, through its Economic Development Fund, offers a Work Local Scholarship/Loan Repayment program to assist businesses in sponsoring youth from the community choosing to go to college or trade school, then returning to live and work in Carrington.

This grant complements the Carrington Strategic Plan and Main Street Revitalization Plan by incentivizing workforce growth and attracting a new generation to Carrington.

## **Scholarship Overview**

**Eligibility Requirements:** Available to any Carrington high school or college student planning to receive a post-secondary degree or certification, and then return to Carrington to work for a sponsoring business, or to assist with student loan repayment within one year of completing a degree or certificate. Must be sponsored by and receive a matching scholarship from a local business.

**Eligible Grant Expenses:** Any expenses related to obtaining a post-secondary degree or trade/skill certification. (Minimum 9-month education program or 3-month internship.)

#### **Application Requirements**

- 1. Complete Scholarship/Loan Repayment Application (attached)
- 2. Provide signed agreement between the sponsoring business and applicant stating terms of the commitment to return to work for said business.

## **Program Requirements**

1. Applicant must enter an agreement to return and work for the sponsoring business. Minimum work period required is 9 months. Details of employment should be negotiated between the business and applicant.

#### **Scholarship Funds Available**

The City will match scholarship/loan repayment funds with a minimum match of \$2,000 and maximum match of \$4,250 per individual applicant. Disbursement of the grant funds will match the schedule of the sponsoring business.

#### **Grant Process**

**Administration:** Completed scholarship applications are to be submitted to the CCEDC office. The CCEDC Board will recommend approval or denial to the Carrington City Council. The City Council shall have final approval authority.
