

Carrington Building Demolition Cost Share

Introduction

The City of Carrington, through its Economic Development Fund, offers a Building Demolition Cost Share Grant to assist owners of dilapidated properties with the removal of any blighted or dangerous structures.

This cost share grant complements the Carrington Strategic Plan and Main Street Revitalization Plan by enhancing community safety and improving the vitality of the city by removing buildings that pose a health/safety hazard.

Cost Share Grant Overview

Eligibility Requirements: Assistance is available to any residential or commercial property owners whose structure(s) has been identified as unlivable, unsafe, dangerous, blighted, slum or condemned by the Carrington Building Official (or their designee).

Eligible Cost Share Grant Expenses: Funds can be used for:

- Demolition of building/structure
- Removal of materials
- Site reclamation
- Reimbursement for required asbestos inspection

Application Requirements

1. Complete Application (attached)
2. Complete an asbestos inspection (must be conducted by a licensed contractor and copy of report must be provided to CCEDC)
 - a. If asbestos is found, applicant must coordinate disposal with ND Solid Waste Program
3. Complete and obtain required City of Carrington demolition permit
4. Provide demolition plan and cost estimate (include disposal plan for all materials including foundations, wood framing, brick/block, roofing, drywall, insulation, plumbing, electrical and mechanical)
5. Provide restoration plan and cost estimate (include earth fill, regrading and seeding)
6. Additional information may be requested.

Program Requirements

1. Applicant must receive approval of Building Demolition Grant PRIOR to commencing work.
2. Demolition must occur within 90 days of the approved application.
3. Site restoration must begin within 30 days of building demolition.
4. All receipts must be submitted with proof of payment to receive reimbursement. Reimbursement shall occur within 30 days after project completion and upon receiving all necessary receipts and proof of payment.

Cost Share Grant Funds Available:

- **25% of total project cost capped at \$10,000 per property (owner retains property upon building demolition)**
- **Up to 75% of project cost if property is deeded to the City of Carrington (including warranty or quit claim deed, title opinion, up-to-date real estate abstracts and payment of any outstanding taxes and specials) within 60 days of demolition**

Grant Process

Administration: Complete cost share grant applications are to be submitted to the CCEDC office. The CCEDC Board will recommend approval or denial to the Carrington City Council. The City Council shall have final approval authority.
