

# Carrington's Commercial Building Construction or Expansion Grant

## Introduction

The City of Carrington, through its Economic Development Fund, offers a Commercial Building Construction or Expansion Grant. This grant initiative is being undertaken to support the construction of new commercial buildings or the expansion of existing commercial buildings within city limits to encourage business growth.

This grant complements the Carrington Strategic Plan and Main Street Revitalization Plan by incentivizing new businesses to develop in the community, as well as existing businesses to grow and expand.

## Grant Overview

**Eligibility Requirements & Eligible Grant Expenses:** Available to any new or existing businesses or commercial entity looking to construct new building(s), expand their building or relocate to a new commercial building that requires expansion within Carrington city limits.

Expansion of an existing commercial building must increase the square footage of the building by a minimum of 25%.

Annual disbursement of grant funds will discontinue if the business a) ceases to operate for a period of 30 days or longer; or b) no longer adheres to the established business plan approved at the time of grant award.

Annual disbursement of funds may continue if the business or building is sold or transferred if a) the new owner/operator adheres to the original business plan; or b) a new business plan is approved and new business begins operating within 90 days of transfer of ownership.

## **Application Requirements**

1. Complete Grant Application (attached)
2. Include detailed business plan
3. Include architectural plans/renderings of new building or building expansion
4. Include total cost estimates including material and labor  
*\*Real estate on which the building is to be located should not be included in the estimated cost.*
5. Additional information may be requested.

## **Grant Process**

**Administration:** Completed grant applications are to be submitted to the CCEDC office. CCEDC Board will recommend approval or denial to the Carrington City Council. The City Council shall have final approval authority.

Upon approval, disbursement of grant funds will begin in December of the calendar year AFTER being placed on the property tax rolls by the Foster County Tax Assessor.
